## WATER MAIN EXTENSION FOR HONEYWELL RESIDENTIAL DEVELOPMENT AND REQUEST FOR CONNECTION FEE CREDIT

Chairman lannaccone stated that Item G of the Other Business portion of the meeting would be moved up on the agenda as courtesy to a representative of K. Hovnanian present at the meeting. John Crane of K. Hovnanian introduced himself to the Board of Members. Mr. Crane was present in connection with a request dated July 8, 2016 to the Authority from Paulus, Sokolowski & Sartor ("PS&S") on behalf of K. Hovnanian at Morris Township II, LLC ("Hovnanian") for connection fee credits in connection with a proposed development to be constructed by Hovnanian at 101 Columbia Road in Morris Township. The Authority has calculated the connection fee for the Development to be \$1,091,271.52. Hovnanian is seeking credits to the calculated connection fee as follows: (i) a credit pursuant to Section 18.5 of the Authority's Rules and Regulations for Water Service ("Tariff") which permits allowances in the form of credits to connection fees in situations where the owner or developer has constructed and paid for offsite improvements and contributed such improvements to the Authority; and (ii) a credit of \$271,579.79 representing the equivalent connection fee for the existing buildings on the Property which are currently connected to the water system of the Authority and being demolished as part of the Development. It was requested that the Board discuss the contract negotiations in closed session.

# WATER MAIN EXTENSION FOR HONEYWELL RESIDENTIAL DEVELOPMENT AND REQUEST FOR CONNECTION FEE CREDIT (continued)

Following discussions held in Closed Session, the Members of the Board discussed and agreed that Hovnanian is entitled to a credit of \$271,579.79 representing the equivalent connection fee for the two existing buildings connected to the water system, which are to be demolished in connection with the Development reducing the Connection from \$1,091,272.52 to \$819,691.73 (the "Adjusted Connection Fee").

The Members of the Board further discussed and found that Hovnanian has agreed to construct and pay for offsite improvements at an estimated cost of \$1,064,501, which improvements are to be contributed to the Authority and that special circumstances exist, pursuant to Section 18.5 of the Tariff, which justify allowance of a further credit to the Adjusted Connection Fee equal to 25% of the Adjusted Connection Fee, or \$204,922.93, resulting in a final Adjusted Connection Fee of \$614,768.80.

A. Resolution Authorizing Award of a Professional Service Contract for Professional Engineering Services in connection with Water Main Replacement within Railroad Right-of-Way

The Board reviewed a memorandum from the Executive Director/Chief Engineer dated July 18, 2016. Ms. Cummings recalled that in November 2011, the Authority awarded a design contract to Suburban Consulting Engineers, Inc. (SCE) and subsequently amended the same contract in February 2012. The result of the design was the award of a water system improvement project, or water main replacement project, to MSP Contractors as part of the 2013 Water System Improvement Project. These improvements included the replacement of 550' of water main located on the north side of the Morristown and Erie right-of-way to Eden Lane. This portion of the project was subsequently removed from the project due to delays encountered securing the Morristown and Erie railroad occupancy permit for the work where the design approach utilized an open-cut method. The open-cut method had presumably been approved by a representative of the Morristown and Erie railroad but was later rejected by RELTek who required the use of a conventional jack and bore method of construction.

In June of 2016, the Authority requested a proposal from SCE to complete the necessary engineering design for this section of main using the jack and bore method or other method approved by the authorized representative of the Morristown and Erie Railroad, to provide consulting services to review the bids, make a recommendation for contract award, and to provide construction administration services.

SCE submitted a proposal to provide such services dated June 30, 2016, in the maximum, not-to-exceed amount of \$28,720, and has complied with the provisions of the New Jersey Pay-to-Play law.

WATER MAIN REPLACEMENT SOUTH JEFFERSON ROAD, TOWNSHIP OF HANOVER

### PROJECT UNDERSTANDING

In accordance with your recent request, SUBURBAN CONSULTING ENGINEERS, INC. (SCE) is pleased to provide the following proposal for engineering services related to the Water Main Replacement on Jefferson Road, located in the Township of Hanover, New Jersey. SCE previously designed the portion of main replacement from the north side of the Morristown and Erie right-of-way to Eden Lane under the 2013 water distribution system improvements. That portion of the project (approximately 550-feet) was removed from the scope of the construction program due to the delays encountered securing the Morristown and Erie railroad occupancy permit for the work. For the purpose of this proposal, a conventional jack and bore easing and carrier pipe across the railroad right-of-way is anticipated.

It is our understanding that Southeast Morris County Municipal Utilities Authority (SMCMUA) desires to advance this portion of the work at this time. It is also our understanding that the method of installation remains undetermined and should be confirmed before the project final design is completed for bidding. In order to evaluate trenchless methods of installation, it will be necessary to conduct geotechnical investigations. Lastly, bid period and construction phase engineering services are also being offered to assist in the completion of this project.

Prior to employment, SCE conducts a reference check for any candidate employees. A thorough interview process is conducted at SCE with multiple managers engaged prior to an offer begin made. SCE will also assist SMCMUA in submitting any, and all required permit applications. SCE has been in contact with ReLTEK, LLC to discuss opening the discussion on this crossing. They have indicated that a new application will be necessary.

### Task 3: Geotechnical Exploration

In cooperation with a sub-contracted Geotechnical firm, SCE will perform the required geotechnical exploration which includes, two twenty foot (2-20) deep test borings will be drilled on either side of the right-of-way.

### Task 4: Preliminary Design and Construction Cost Estimate

SCE will meet with the SMCMUA's project team to discuss the recommendation for design; method of installation and the estimated project construction costs. Estimated costs at the preliminary design phase will be based on the American Society of Professional Estimators (ASPE) Level 2 Schematic/Conceptual Design Standard, SCE will define other equivalent construction cost estimate standards for use in this task, and the selection of the installation approach will be memorialized in a base of design memorandum.

### Task 5: Final Design and Specifications

SCE will finalize design plans and cost estimate and prepare detailed Technical Specifications to be included in the SMCMUA standard Bid Documents. Estimated costs will be based on the American Society of Professional Estimators (ASPE) Level 4 Construction/Bid Design Standard. SCE will define other equivalent construction cost estimate standards for use in this task. Included in this phase will be the finalization of the ReLTEK, LLC permit application, which is the only other submitted approval necessary for advancement off the project.

### Task 6: Pre-Bid Tasks and Post-Bid Review and Recommendation for Award

SCE will coordinate necessary pre-bid meetings with potential bidders, including site visits. SCE will be present at Bid Opening, record bids, thoroughly review the Bid submittals received and submit a written recommendation for award. SCE will also respond in writing to any questions regarding the bids prior to the bid submittal date.

### Task 7: Contract Administration

SCE will provide contract administration services to include shop drawing submittal review, design clarifications, payment recommendations, preparation and review of punch list, coordination with the rail road representatives and other entities, and project closeout. Part-time construction inspection services will also be provided. SCE has estimated 80 man-hours for part-time inspection.

Project closeout will include the preparation and submittal of "As-Built" drawings in AutoCAD 2010 format.

# RESOLUTION APPROVING CREDITS TO CONNECTION FEE FOR PROPOSED DEVELOPMENT LOCATED AT 101 COLUMBIA ROAD IN MORRIS TOWNSHIP, NEW JERSEY

WHEREAS, the Authority has received a request dated July 8, 2016 from Paulus, Sokolowski & Sartor ("PS&S") on behalf of K. Hovnanian at Morris Township II, LLC ("Hovnanian") for connection fee credits in connection with a proposed development to be constructed by Hovnanian at 101 Columbia Road in Morris Township (the "Development"); a copy of which request is annexed hereto and made part hereof; and

WHEREAS, the Authority has calculated the connection fee for the Development to be \$1,091,271.52; and

WHEREAS, Hovnanian is seeking credits to the calculated connection fee as follows: (i) a credit pursuant to Section 18.5 of the Authority's Rules and Regulations for Water Service ("Tariff") which permits allowances in the form of credits to connection fees in situations where the owner or developer has constructed and paid for offsite improvements and contributed such improvements to the Authority; and (ii) a credit of \$271,579.79 representing the equivalent connection fee for the existing buildings on the Property which are currently connected to the water system of the Authority and being demolished as part of the Development; and

WHEREAS, the Authority finds that Hovnanian is entitled to credit of \$271,579.79 representing the equivalent connection fee for the two existing buildings connected to the water system, which are to be demolished in connection with the Development reducing the Connection from \$1,091,272.52 to \$819,691.73 (the "Adjusted Connection Fee"); and

WHEREAS, the Authority further finds that Hovnanian has agreed to construct and pay for offsite improvements at an estimated cost of \$1,064,501, which improvements are to be contributed to the Authority and that special circumstances exist, pursuant to Section 18.5 of the Tariff, which justify allowance of a further credit to the Adjusted Connection Fee equal to 25% of the Adjusted Connection Fee, or \$204,922.93, resulting in a final Adjusted Connection Fee of \$614,768.80.
