

PAYMENT OPTIONS

Bills are payable in full by the due date. Interest in the amount of 1½% per month will be charged on unpaid balances 30 days from the bill date.

BY MAIL – For your convenience, please use the enclosed envelope, include your bill stub and mail to our lockbox address shown on the front side of bill.

DIRECT PAYMENT – Direct payment automatically deducts your water bill payment from your checking account. Call our office for an application form.

OUR WEBSITE – You can now pay your water bill online through our website (www.smcmua.org) using the E-check option. Checking accounts only. **(Note: No Debit or Credit Cards)**

IN PERSON – Payments may be made at our Customer Service Center during regular business hours.

DROP BOX – You may also leave your payment (check or money order) in our drop box day or night. The drop box is located outside of the Customer Service Center entrance.

RATE SCHEDULE – A rate schedule is available upon request and can also be found on our website.

CONSUMPTION UNIT OF MEASURE – One consumption unit = 100 cubic feet = 748 gallons.

PRORATED BILLS – Prorated bills are for a partial billing period or a period longer than the normal billing period.

ESTIMATED BILLS – Bills will be estimated if we are unable to obtain an actual meter reading.

FINAL BILLS – When a customer is moving out, we must be notified in writing to arrange a final meter reading. Customer is responsible for all charges until a final reading is taken.

FACILITIES CHARGE – This charge is based on the size of the meter. It covers the cost of water service lines, meter installations, meter readings, billing costs and other expenses.

WATER MAY BE TURNED OFF FOR THE FOLLOWING REASONS:

- 1. Failure on the part of the customer to sign for service and pay a deposit if applicable.
- Failure to provide us with access to the premises for a meter reading, meter change or to install new equipment.
- 3. Nonpayment of bills. Unpaid water bills constitute a lien on the property (N.J. Statues, Title 40:14B-42).
- 4. Any other violation of the rules and regulations of the Authority.

EMPLOYEE IDENTIFICATION – All company service employees carry identification badges that include employee's name, photo and date card was issued. Please ask to see it.

LEAKS ON CUSTOMER'S PREMISES – <u>Owners</u> are responsible for their property, therefore, no credit adjustments will be given for high bills due to leaks.

Water accounts must be in property owner's name.
